We ask your cooperation, as a contestant, to abide by the rules set forth herein to achieve for all of us, in the sport of "Cowboy Action Shooting", a fun and safe event.

1. Alcohol is not permitted at Black Creek Shooter's Association Ranges at any time. If a Violation occurs, you will be asked to leave the premises. No drugs are allowed on any part of the range. Use of any type or form will mean disqualification of the shooter and automatic removal from the range.

2. No loaded weapons behind the firing lines, or spectator's area. Guns are to be loaded and unloaded in designated areas only. Rifle and shotgun actions will remain open until they are loaded. Pistols will remain in holster until you are on the firing line. No gun handling behind the firing line. We are shooting on cold range rules.

3. Safety glasses must be worn at all times. Hearing protection is recommended.

4. KC's Corral is a SASS affiliated club. We follow SASS guidelines; therefore all SASS legal items are permitted or as approved by the Range Master. Weapons and ammo: Only Single Action revolvers, Lever Action Rifles of 25 caliber or larger, double barrel (side by side) shotgun, '97 and lever action shotguns are OK. No ejectors or jacketed, gas checked ammo allowed. Dress must be old west. No tennis shoes, t-shirts, ball caps, etc.

I understand that I am participating in a sport, in which certain dangers, risks and death may arise, including, but not limited to, accidental injury, the force of nature and illness. In consideration of the right to participate in this event, and the service provided me by the Black Creek Shooter's Association; I hereby release the club, its' officers, its' directors; and it's agents from all liability that results from damage or injury occurring either to myself or to a member of my family or my guest during the use of the club facilities or our presence thereon. Without limiting my waiver and release in any fashion or meaner, I specifically release the club, its' officers, its' directors, and its' agents from any and all causes of action or claims from compensation without regard as to whether such cause of action or claims for compensation lie in tort; contract or otherwise. I further release the club from liability for any and all consequential damages that accrue to me or my family on the account of, or growing out of our use of the club facilities or in participation in any club event no matter where such event may occur. I have and do hereby assume the risks associated with such. I shall, at my own expense, defend management and/or all sponsors, their members or employees from all such claims and indemnify, from any and all liability, damages and cost arising from any injury of any kind to persons or property occasioned by any act or omission committed by me.
